### **LWVUS Convention 2024 News**

The 2024 National Convention was held in Washington DC June 27-30<sup>th</sup>. Every state plus Washington DC and the Virgin Islands was represented in person or virtually. The League is one of the most impactful organizations in the US for Voter Services. There is no time to hold back. We run toward problems to solve them. We do not cower. We file lawsuits and in court show up with our graphs, charts, and extensive research. We have the ear of Congress, VA General Assembly and the Judicial System. It was announced that the new chief executive officer for LWVUS will be: Celina Stewart. Celina has been part of LWVUS staff since 2018 and currently serves as chief counsel and senior director of advocacy and litigation. She shared about her vision for her leadership of the next era of the League's story, focusing on the phrase: "Together, we will." Some highlights include-

Positions and Resolutions Approved include-

Making Democracy Work will continue for the next 2 years.

- · Study of Federal Judiciary Looking for local league members to join the Committee.
- · Retention of all LWV US positions in the areas of Representative Government, International Relations, Natural Resources and Social Issues as outlined in Impact on Issues
- · Concurrence with the LWV of Washington state positions on Decline of Local News and its impact on Democracy

Other Initiatives that were discussed include One Person One Vote- the elimination of the Electoral College. This is happening at the State Level. National Popular Vote has been enacted by 16 states. https://www.nationalpopularvote.com/

The Vermont Concurrence regarding the position on US Privatization of Healthcare was discussed and debated but did not pass by the 2/3 majority required. Some delegates were confused by the position and felt there needed to be further education about privatization of healthcare. Stay tuned for a Local Community Dialog being planned for fall of 2024.

Other Motions Approved include.

- DC Statehood
- LWVUS commits continuing support for the CEDAW framework at the local, state, and national levels to protect and promote the fundamental and inalienable human rights of women and girls.
- Fair and Humane Immigration Reform
- Reproductive Rights and Justice

Natural Resources Committee by Linda Goodling

The Natural Resources Committee has been studying the revision of the Albemarle County **Comprehensive Plan**, known as AC44. Growth Management should be at the core of every county policy in The Comprehensive Plan. We are concerned that strong policies be in place for preserving rural areas, land use, and water resources, among other issues.

After 3 years of developing the Plan, it will undergo a refinement. To the public, it is not clear at this time what is being changed, shortened, or eliminated. We encourage more community engagement during this next phase, and that the public be informed of which goals and objectives are being revised or eliminated, and to have access to the documents that identify these changes. We especially hope that the rural areas are strongly protected and that smart growth occurs in the development area.

One of the League's missions is to "encourage informed and active participation." Therefore, we are very concerned about the absence of community involvement and opportunities to speak at meetings. So, we hope that the League can participate in the upcoming meetings.
